A deposit of at least \$100.00 must accompany this fully completed agreement when mailed or faxed to MWF. **THE FULL RENTAL FEE MUST BE PAID NO LATER THAN JULY 1, 2010 OR THE EXHIBITOR WILL LOSE HIS OR HER RESERVED SPACE.** No exceptions will be granted. PRICES: Booth rental for one 10' X 10' (includes a 6' draped table, one chair, waste basket, and back and side drapes) is \$500 (end caps are \$550 per booth). Outside space is sold by the square foot (with a 100 square foot minimum) at \$2 per square foot, **and is sold only at the discretion of MWF.** If outside electricity is needed, there will be a \$75 additional charge. The exhibits coordinator at MWF reserves the right to modify the floor plan to the extent necessary for the best interest of the exhibitors and the show. I further understand that the booth rental fee is non-refundable and non-transferable. I also understand that no sub-leases are permitted and any exhibitor attempting to sub-lease may be expelled at the discretion of MWF and all rentals forfeited. In addition to the above, I understand that all business must be conducted within the exhibitor's booth and that no exceptions will be granted. I further agree to conduct myself and my business (including products sold) in a manner conducive to a family atmosphere. I agree to refrain from exhibiting videos, photographs, graphic art or other media that, in the judgment of MWF, are offensive, depict illegal or unethical hunting practices (except for educational purposes by law enforcement or related agency exhibitors) or depict kill scenes which do not reflect fair chase hunting methods. Exhibitors who do not comply will be asked to leave and all rentals will be forfeited.
